# **Minutes of Board Meeting**

## Tuesday, February 25, 2020 5:00 P.M.

#### Meeting opening

Chairman Lehman called the meeting to order at 5:02 p.m. and led the Pledge of Allegiance. The Board meeting was held at 201 E. Main Street, Durham, NC 27701 in Room 126.

#### **Approval of Agenda**

Mr. Bowens presented the Board with the agenda for the meeting. Following review, Ms. Baxton moved to approve the agenda and all approved, 5-0

#### **Approval of Minutes**

Mr. Bowens presented the Board with minutes from the 02/18/2020 and 02/20/2020 Board meetings. Following review, Ms. Oxendine made a motion to approve the minutes and all approved, 5-0. Chairman Lehman made the motion.

#### New Business

- a. Review of Absentee Ballots
  - After review of the absentee ballot applications, Chairman Lehman moved to approve 10, 819 applications and ballots per the recommendation of staff (includes absentee-by-mail and absentee one-stop). The motion was seconded by Ms. Baxton and approved by all, 5-0.
  - Ms. Baxton moved to reject 7 applications and ballots per the recommendation of staff. The deficiencies were due to the voter and/or witnesses insufficiently completing the absentee return envelope. The motion was approved by all, 5-0.
  - Ms. Baxton made a motion for staff to duplicate non machine-readable ballots and scan all approved absentee ballots as preparatory steps prior to the count on Election Day in accordance with NCGS 163-234 (2) and (3). The motion was approved by all, 5-0.
- b. 2020 Primary Election Chief Judge and Judge Substitutes
  - Mr. Gray moved to approve the replacement judges as recommended by staff. Chairman Lehman seconded the motion and all approved, 5-0.

### **Public Comments and Questions**

Public comments and questions were provided by two members of the public.

### **General Discussion**

Mr. Bowens provided the Board and public with an update on early voting. Mr. Willie Darby provided an update on the voting enclosure for Precinct 01 - W.J. Brogden Middle School. Voting will continue to take place in the Auditorium for the March Primary and will be moved to the Gym for the November General Election.

## **Closed Session**

Chairman Lehman moved for the Board to meet in closed session as allowed under N.C. Gen. Stat. §§ 143-318.11(a)(1) to discuss a confidential legal matter. The motion was approved by all, 5-0. The Board met in closed session from approximately 5:34 p.m. to 5:48 p.m. At the end of the closed session, the Board returned to open session on a motion by Chairman Lehman, which was approved by all 5-0.

#### <u>Adjournment</u>

The Board adjourned at approximately 5:48 p.m. on a motion made by Mr. Irby. The motion was approved by all, 5-0.
