# **Meeting Opening**

Chairwoman Baxton called the meeting to order at approximately 2:00 p.m. at the Board of Elections Warehouse (2445 S. Alston Ave, Durham, NC 27713) and led the Pledge of Allegiance.

# Approval of Agenda

Mr. Bowens presented the Board with the agenda for the meeting. Following review, Mrs. Oxendine moved to approve the agenda as submitted by staff. The motion carried unanimously, 4-0. Mr. Boone was not present for this meeting.

## **Public Comment**

No comments or questions were provided.

# **New Business**

- a. Sample Audit Count (One-Stop East and Precinct 25)
  - Mr. Bowens presented the Board with a request for staff to conduct the sample audit count for One-Stop site East Regional Library and Precinct 25. Mr. Lehman moved to authorize staff to proceed with the sample audit count. The motion carried unanimously, 4-0.

#### b. Review and Counting of Provisional Ballots

Mr. Bowens presented the Board with Provisional ballot applications for review. Following
discussion and review, Mrs. Oxendine moved to approve 319 fully counted and 247 partially
counted provisional ballots and applications as recommended by staff. The motion carried
unanimously, 4-0. Mrs. Oxendine also moved to disapprove 790 applications as recommended
by staff. The motion carried unanimously, 4-0.

## c. Review and Counting of Supplemental Absentee Ballots

- Mr. Bowens presented the Board with 1333 Civilian, 11 Accepted Cure, 15 Military and 172
   Overseas duplicated absentee ballots and applications for approval. Following discussion and
   physical review, Mr. Lehman moved to approve a total of 1333 Civilian, 11 Accepted Cure, 15
   Military and 172 Overseas duplicated absentee ballots and applications per the
   recommendation of staff. The motion passed unanimously, 4-0.
- Mr. Bowens presented the Board with 83 ballots and applications that were Returned After Deadline, 25 ballots and applications with Witness Information Missing, 3 pending ballots and applications with unclear postmarks, 1 ballot and application that was not properly notarized and 1 ballot and application that was missing Assistant Information. Following discussion and review, Mr. Lehman moved to disapprove the 113 ballots. The motion passed unanimously, 4-0.
- Following the motions for the ballots that were not accepted, the approved absentee counts for the November 17, 2022, meeting was 1333 Civilian, 11 Accepted Cure, 15 Military and 172 Overseas duplicated ballots. The total approved absentee count was 1531.

#### **General Discussion**

Mr. Bowens informed the Board that the Canvass meeting would occur at 11:00 a.m. on November 18, 2022.

## **Adjournment**

The Board adjourned at approximately 9:20 p.m. on a motion made by Mr. Lehman. The motion carried unanimously, 4-0.
