## **Meeting Opening**

Chairwoman Baxton called the meeting to order at approximately 2:00 p.m. at the Durham County Board of Elections Warehouse (2445 S. Alston Ave, Durham, NC 27713) and led the Pledge of Allegiance.

# Approval of Agenda

Mr. Bowens presented the Board with the agenda for the meeting. Following review, Mr. Beskind moved to approve the agenda as submitted by staff. The motion carried unanimously, 5-0.

#### **Public Comment**

One public comment was provided in the chat function and addressed by Mr. Bowens.

#### **New Business**

#### a. Counting of Absentee Ballots

The Board began its count of all absentee ballots per a previously passed resolution. The polls were closed on voting equipment used to count absentee ballots from the early voting period. The Board reviewed this process and once complete, signed results tapes printed from the tabulators. Following the signing of results tapes, Mrs. Oxendine moved to authorize staff to upload election results into the tabulation software and publish them to the State Board of Elections website. The motion passed unanimously, 5-0.

### b. Closed Session (NCGS §143-318.11(a)(3))

Dr. Weaver moved that the Board enter into closed session at 2:25 p.m. under NCGS §143-318.11(a)(3) to discuss matters concerning Voto Latino et al. v. Hirsch et al. The motion carried unanimously, 5-0.

• The Board retuned to open session at 2:33 p.m. in accordance with NCGS §143-318.10(d) to conduct business remaining before the Board.

# **General Discussion**

Mr. Bowens provided the Board with an update on Election Day activities and staff preparations for Election Night Returns.

### Recess

The Board recessed at approximately 2:37 p.m. and unanimously agreed to reconvene at 7:30 p.m. for the closing of the polls and Election Night Returns. Board members oversaw the receipt and upload of election results from the 58 precincts that were open for the 2023 Municipal General Election.
