## **Meeting Opening**

Chairwoman Baxton called the meeting to order at approximately 5:30 p.m. at the Durham County Board of Elections Warehouse (2445 S. Alston Ave, Durham, NC 27713) and led the Pledge of Allegiance.

#### **New Business**

a. Board of Elections Production of Certain Spanish Language Materials

• Mr. Bowens presented the Board with a request to instruct staff as to the next steps regarding the production of certain outreach materials in Spanish. The Board discussed this item at their meeting on January 30, 2024, and instructed staff to provide language statistics for the Durham County population. Staff transmitted the data to the Board on June 3, 2024, for review. Following discussion and review, the Board tabled the motion for production of certain outreach materials until all Board members are present.

## b. Approval of Early Voting Sites at Southern High School and DTCC

• Mr. Bowens presented the Board with a request to approve the proposed on-campus voting locations for Southern High School (Fitness Room) and Durham Technical Community College (William J. Ingram Center – Multi-Purpose Room). Following discussion and review, Mr. Boone moved to accept the proposed location for Southern High School. The motion passed unanimously, 4-0. Mrs. Oxendine moved to accept the proposed location for Durham Technical Community College. The motion passed unanimously, 4-0.
